

Introduction and Methods

This brief report evaluates year-over-year employee FTE¹ changes comparing February 2020 to February 2021 payroll data². The February timeframe aligns with reporting done by the University of Illinois System Office. Methods in producing the report include the following:

- Active appointments as of February 10th of the reporting year are included.
- Administrators with tenure-system appointments with zero FTE are counted as *academic professionals*.
- Librarians are counted as faculty and they are represented by the collective bargaining agreement.
- *Tenured faculty* are identified by Banner tenure codes of either A or K.
- *Tenure track faculty* are identified by Banner tenure codes of Q or 1-7.
- *Other faculty* include instructors, lecturers, research associates, teaching associates, post docs, adjuncts, department affiliates, cooperating teachers, visiting scholars, artists in residence, and all others with faculty appointments, but with tenure codes of N, T, or W.
- The FTE of department heads, department chairs, assistant and associate department heads/chairs are counted as *Other Faculty*.
- Employees with appointments split across campuses, colleges or departments are counted by their FTE in those units.

All Funds Summary

Table 1 below details changes by employee classifications paid from all fund sources. UIC had 26.7 fewer faculty FTE in February 2021 as compared to February 2020. The large decline in “Other Faculty” (-25.1) is likely attributed to a decline in course sections due to COVID-19. The number of academic professionals increased by 53.2 FTE, whereas Civil Service staff decreased by 5.3 FTE³. Graduate Assistants and House Staff (Medical Residents) decreased by 5.9 FTE, for a total net change of +15.4 FTE (+0.15%).

¹ Full Time Equivalency (FTE) data are from the HR payroll system with 1.0 FTE equal to a full-time appointment. The data in this report are from February annual payroll snapshots that allow for year-to-year comparisons. The data do not facilitate the tracking of positions and vacant positions.

² This timeframe is consistent with analysis performed by the UI System Administration.

³ Civil Service hiring may have experienced declines due to COVID-19 related factors such as the inability to complete testing and or due to the nature of the work entailed by those classifications.

State Funds Summary

Table 2 below includes only state (and tuition) funded employee FTEs. State funded faculty positions decreased by 46 FTE. More than half (54%) of that decrease occurred with adjunct, clinical, and visiting faculty. Likely related to their enrollment decline in fall 2020 (see table 9), Liberal Arts and Sciences saw the largest FTE decrease in non-tenured faculty (see table 4, -11.6% from all fund sources, -11.9% from state funds). State funded academic professionals decreased by 24.8 FTE. Civil Service employees paid from state funds increased by 8.7 FTE. Graduate Assistants declined by 47.8 FTE, and House Staff increased by 4.6 FTE, for a total reduction of 86.3 FTEs (-1.6%) paid from state funds as compared to last year at the same time.

Summary of Administrative, Professional, Technical, and Clerical Staff (*Academic Professional & Civil Service*)

Tables 5 and 6 summarize administrative, professional, technical and clerical staff (academic professionals and civil service staff). Table 5 summarizes staff by administrative units. Table 6 summarizes staff by the colleges.

In Table 6 below, the College of Medicine (COM) had an increase of 40 staff FTE. This compares to the UIC total increase of 47.9 staff FTE seen in Table 1. Thus, the increase in staff FTE in the COM represents 84% of the total increase. In table 5, the increase of 4.8 staff FTE in the Chancellor’s units is attributed to the reorganization of Public & Government Affairs.

Student Enrollments
