Re: Spring 2024 Ten-day Census – Official Enrollment Data

Enclosed are UIC's official spring enrollment data as of the tenth-day census. Figures are generally in line with expectations and typical enrollment patterns given the Fall 2023 census. Below are highlights.

Enrollment Trends

- UIC's total spring 2024 enrollment is 31,188, a decrement of -0.09% (-28 students) from the spring 2023 enrollment of 31,216.
- Historically total spring enrollment is lower than total fall enrollment. The difference in spring 2024 enrollments (31,188) as compared to fall 2023 (33,522) is -7.0% (-2,334). The fall to spring total enrollment percentage difference has ranged from -4.4% to -7.5% over the last fifteen years and the enrollment count difference has ranged from -1,170 to -2,556.
- This spring attrition was lower than the total from spring 2023, showing an overall improvement of 0.05%.
- Compared to last spring by student level, enrollments were up at the undergraduate level but down at the graduate and professional levels. Undergraduate enrollments increased 1.43% (285), graduate enrollments declined -4.05% (-290), and professional enrollments declined by -0.56% (-23).
- The overall annual increase in spring enrollments (spring to spring) showed an improvement relative to the pattern in the fall (fall to fall). Fall 2023 enrollments declined by -0.7% compared to -0.09% in spring 2024.
- The annual change in undergraduate enrollments was roughly equivalent in the spring compared to the fall, with both metrics showing a 1.4% increase.
- Graduate enrollments are down -4.05% this spring compared to a decrease of -6.2% in the fall. The differences in the graduate subsets are highlighted in Table 2 of the attachment. The largest decline in counts was in the continuing student set (-4.4%).
- Professional enrollments are also down -0.09% this spring, compared to the -1.0% decrease in fall 2023.

- For undergraduate enrollments, compared to last spring by student type, continuing student enrollments increased by 1.78% (336), first-time first-year enrollments are up 21% (25), and new first-time transfer enrollments decreased by -8.9% (-58).
- There are 1,123 UIC Global undergraduate students enrolled in spring 2024, and there are 66 UIC Global students among the 144 new first-time first-years. This is an increase of 30 students compared to UIC Global students enrolled in spring 2023 (1,093). There are 230 UIC Global graduate students in spring 2023, a decrease of -7 students compared to spring 2023 (230).
- Enrollments by college are included in the attached tables 3-6. This includes separate tables of undergraduate, graduate and professional students by student type.

Degrees Conferred in December

- A total of 2,260 students graduated in December 2023, of which 1,451 were undergraduates and 733 were graduates and 76 professional students. Total graduations across all levels in December 2022 were 2,369 so the current totals represent a decrease of -109. Undergraduate graduations were up slightly from 1,414 in December 2022. Graduate and Professional graduations were down from a total of 955, a decrease of -146.

Undergraduate Retention Fall to Spring

- The fall 2023 to spring 2024 retention rates for first-time full-time students was 91.1%. In comparison, the retention rate from fall 2022 to spring 2023 was 89.9% and the retention rate from fall 2021 to spring 2022 was 88.6%. The highest fall to spring retention rate in recent years was for the fall 2014 new first-time full-time first-years, with a spring retention rate of 92.5%. Retention rates are included in the attachment table 9.
